

Data Retention Policy

Command Rooms is committed to protecting your privacy and ensuring the security of your personal data. This Data Retention Policy outlines our practices regarding the retention and deletion of personal information collected through our website ("Website"). We adhere to applicable data protection laws and regulations, including the General Data Protection Regulation (GDPR) and other relevant legislation.

Purpose and Scope
